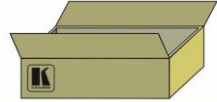


VA-101P12, VA-102P12 Quick Start Guide

Step 1: Check what's in the box

- VA-101P12 or VA-102P12 Power Supply
- 5 or 10 DC power cords
- 1 Quick Start sheet
- 4 Rubber feet



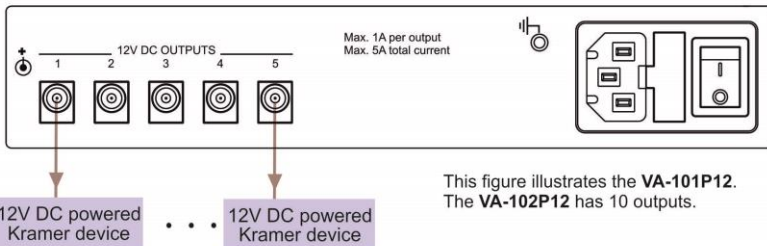
Save the original box and packaging in case you need to return your VA-101P12, VA-102P12 to the factory.

Step 2: Install the VA-101P12, VA-102P12

Mount the machine in a rack (using the **RK-1** rack adapter) or place on a flat surface.

Step 3: Connect the power outputs

Always switch off the power on each device before connecting it to your VA-101P12, VA-102P12.



Step 4: Connect the device power

Connect the power cord to the VA-101P12, VA-102P12 and plug it into the mains electricity.



Step 5: Operate the VA-101P12, VA-102P12

Switch on the power.

2.1 Achieving the Best Performance

To achieve the best performance:

- Use only good quality connection cables (we recommend Kramer high-performance, high-resolution cables) to avoid interference, deterioration in signal quality due to poor matching, and elevated noise levels (often associated with low quality cables)
- Do not secure the cables in tight bundles or roll the slack into tight coils
- Avoid interference from neighboring electrical appliances that may adversely influence signal quality and position your Kramer **VA-101P12**, **VA-102P12** away from moisture, excessive sunlight and dust



This equipment is to be used only inside a building. It may only be connected to other equipment that is installed inside a building.

2.2 Safety Instructions



Caution: There are no operator serviceable parts inside the unit

Warning: Use only the power cord that is supplied with the unit

Warning: Do not open the unit. High voltages can cause electrical shock! Servicing by qualified personnel only

Warning: Disconnect the power and unplug the unit from the wall before installing

2.3 Recycling Kramer Products

The Waste Electrical and Electronic Equipment (WEEE) Directive 2002/96/EC aims to reduce the amount of WEEE sent for disposal to landfill or incineration by requiring it to be collected and recycled. 2.4 Accessory to Medical Equipment (IEC 60601-1)

Both the **VA-101P12** and the **VA-102P12** are certified according to the IEC 60601-1-2, Clause 2.1.3, Medical Electrical Equipment, Part 1: General Requirements for EMC standard which is required when accessory devices are used at locations where medical personnel and patients are present.

In this environment, the **VA-101P12** and the **VA-102P12** can be added to the system **ONLY** if the connecting equipment has been evaluated and meets the IEC 60601-1-2 EMC standards. Note, that when attaching accessory devices to a digital or analog interface, they must comply with the IEC standard for which they are used: for EMC Standard (IEC 60601-1-2), Information Technology equipment (IEC 60950-1 (2ed)).

3 Overview

The **VA-101P12** and **VA-102P12** are 5- and 10-output power supplies used for powering 12V DC powered devices. The **VA-101P12** can supply a maximum of 1A of current to each of five devices for a total of 5A current. The **VA-102P12** can supply a maximum of 1A of current to each of ten devices for a total of 10A current.

The power supplies are especially useful in high-population installations for saving space and eliminating a large number of 12V DC power adapters.

3.1 Defining the VA-101P12 12V DC Power Supply

This section defines the 5-output **VA-101P12**.

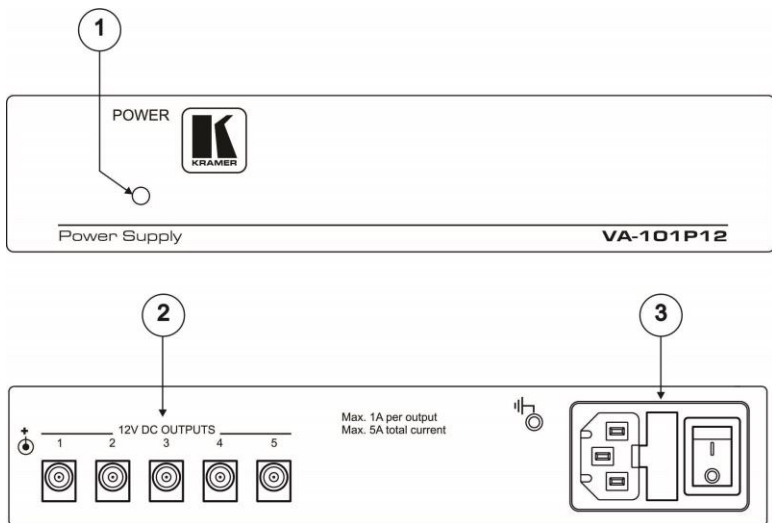


Figure 1: VA-101P12 5-Output 12V DC Power Supply

#	Feature	Function
1	Power LED	Illuminates when the power is turned on
2	12V DC Output Connectors	Supplies 12V DC to up to 5 devices
3	Power Connector, Fuse and Switch	Connects to the mains supply and switches the device on and off

3.2 Defining the VA-102P12 12V DC Power Supply

This section defines the 10-output **VA-102P12**.

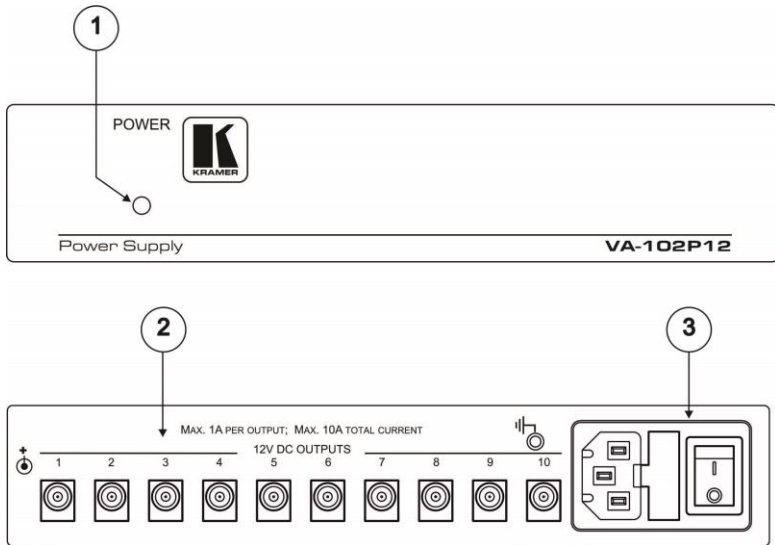


Figure 2: VA-102P12 10-Output 12V DC Power Supply

#	Feature	Function
1	Power LED	Illuminates when the power is turned on
2	12V DC Output Connectors	Supplies 12V DC to up to 10 devices
3	Power Connector, Fuse and Switch	Connects to the mains supply and switches the device on and off

4 Connecting the VA-101P12, VA-102P12



Always switch off the power to each device before connecting it to your **VA-101P12**, **VA-102P12**. After connecting your **VA-101P12**, **VA-102P12**, connect its power and then switch on the power to each device.

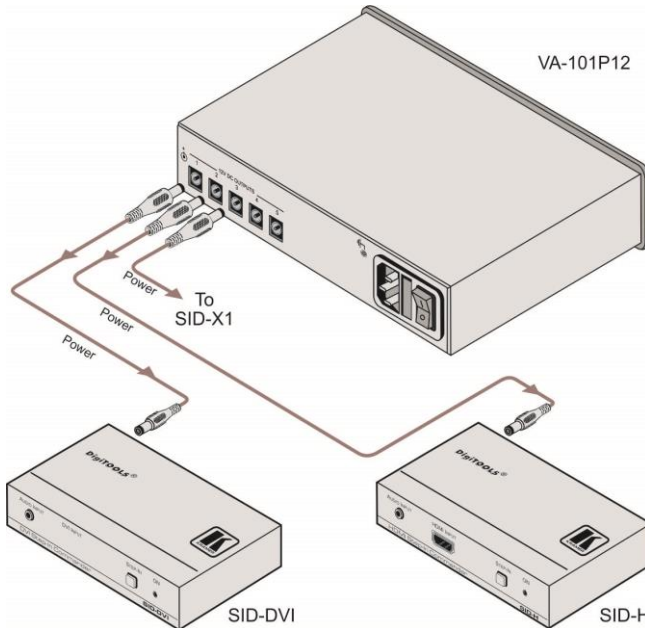


Figure 3: Connecting the VA-101P12, VA-102P12 Power Supply

To connect the **VA-101P12**, **VA-102P12** as illustrated in the example in [Figure 3](#): [Figure 3](#) illustrates the **VA-101P12**. The **VA-102P12** has 10 outputs.

1. Connect the 12V DC outputs to up to five (for the **VA-101P12**) or ten (for the **VA-102P12**) devices.
2. Connect the AC power cord to the AC receptacle and turn ON the power to the **VA-101P12**, **VA-102P12**.

Who is Covered

What Kramer Electronics will do

Kramer Electronics will, at its sole option, provide one of the following three remedies to whatever extent it shall deem necessary to satisfy a proper claim under this limited warranty:

1. Elect to repair or facilitate the repair of any defective parts within a reasonable period of time, free of any charge for the necessary parts and labor to complete the repair and restore this product to its proper operating condition. Kramer Electronics will also pay the shipping costs necessary to return this product once the repair is complete.
2. Replace this product with a direct replacement or with a similar product deemed by Kramer Electronics to perform substantially the same function as the original product.
3. Issue a refund of the original purchase price less depreciation to be determined based on the age of the product at the time remedy is sought under this limited warranty.
